# 1. Letter from the Eurosite President



# 3. Implementing the Eurosite Strategy 2015-2020

Following the adoption of the new Eurosite Strategy 2015-2020 in January 2015, in 2017 the following actions were implemented in line with the agreed Eurosite objectives.

Objective 1: Networking for Europe's nature - Eurosite is recognised as a vital, relevant and active network organisation with a solid, essential agenda for European nature

Priority Activity 1: Workshops and field meetings on key issues - recognising the importance of face to face contact

The clear prioritisation of this activity reflects the central role that networking and field meetings have played over Eurosite's 28 year history. That is why until the end of 2017, Eurosite has been a member of the ECNC-led consortium delivering the implementation of the Natura 2000 Biogeographical Process, which clearly prioritises the importance of networking and knowledge sharing.

# The Natura 2000 Biogeographical Process - networking

In 2015, the European Commission, with support from the Natura 2000 Biogeographical Process consortium, launched the next phase of the Process (2015-2017), which builds on the success of previous Biogeographical Seminars and Thematic networking events organised around key issues identified during Seminars.

In 2017, there were six Natura 2000 Biogeographical Process networking events, two of which were co-organised by Eurosite.

# Natura 2000 Monitoring workshop, 4-6 April, Litoměřice, Czech Republic

On 4-6 April 2017, in Litoměřice, Czech Republic, Eurosite organised its third Natura 2000 Monitoring Workshop: Developing conservation management objectives and condition indicators for monitoring on Natura 2000 sites. The workshop was organised as a thematic networking event of the Natura 2000 Biogeographical Process and it was hosted by Eurosite member Krkonoše Mountains National Park. The topic attracted some 45 participants from across Europe.

The workshop has confirmed that developed condition indicators ensure that conservation management can actually be monitored. Condition indicators are important because they allow us to develop efficient and reliable monitoring methods that will directly inform site management. Regarding the decision-making process, several questions were raised like whether or not a habitat can still realistically achieve Favourable Conservation Status (FCS) if it no longer supports the species that should be present.

As a follow-up of the workshop a guidence document will be developed. Following the needs expressed by the participants during the workshop, this guidance will cover the following topics:

- the role of condition indicators:
- how and where to find existing indicators;
- selection criteria, e.g. simple / robust but fit for purpose and budget;
- how key or 'typical' (animal or plant) species can be linked to site-specific habitat attributes to define favourable status;
- how plant and animal species assemblages can be used to form proxy condition indicators;
- facilitating communication and collaboration between habitat and species experts;
- identifying and defining negative indicators (e.g. invasive species, threats);
- setting measurable limits (quantitative and qualitative);
- options for data collection i.e. sampling methodologies;
- options for QA and validation.

Participants were very keen to attend the next workshop from the Monitoring Series. Following their interest this workshop will be focusing on the roles of remote sensing and related new technologies in Natura 2000 monitoring.

# Natura 2000 Biogeographical Process thematic networking event on ecologically justifiable Low Hanging Fruits, 27 September 2017, Espoo, Finland

On 27 September Eurosite and Metsähallitus Parks and Wildlife Finland organised a thematic networking event of the Natura 2000 Biogeographical Process on ecologically justifiable Low Hanging Fruits in restoration and nature management as part of the Eurosite Annual Meeting 2017.

The event was kicked-off by an introduction by Angelika Rubin of the European Commission explaining the European policy context for this approach (the 'why') and the definition (the 'what'). Low Hanging Fruits are in this context defined as "Features for which an improved conservation status on biogeographical level could be reached with the least possible effort (e.g. by improving only few parameters in one or two Member States)".

During the past year, Finland has invested a lot of work in the development of this approach and has used the opportunity to present the results on this occasion.

Participants learned about the Finnish approach to identifying the socially relevant Low Hanging Fruits and the role of scale when selecting these (national versus European versus global). An ecologically justifiable Restoration Prioritisation Framework, developed and applied in Finland, was also presented. Both approaches are already being applied in Finland, and the initial analyses have shown that it is possible to make significant savings while still achieving the maximum effect or restoration.

The Boreal Member States were invited by Finland to compile and submit their national data as Finland is willing to support them in processing it in order to apply and fine-tune the Finnish methodology in determining their own national Low Hanging Fruits and restoration priorities.

# Second Mediterranean Natura 2000 Biogeographical Seminar, 14-16 November, Limassol, Cyprus

About 100 participants from all 9 EU Mediterranean countries attended the Second Mediterranean Biogeographical Seminar. Organised by Eurosite as part of the Natura 2000 Biogeographical Process, the event aimed to improve and strengthen implementation of Natura 2000 in the Mediterranean region and ensure progress towards the EU 2020 Biodiversity Strategy targets. Specific attention was given to drafting a roadmap of actions for further cooperation on the improvement of the conservation status of Natura 2000 habitats at the biogeographical level. Eurosite used this opportunity to present the LIFE project 'European Private Land Conservation Network - LIFE ELCN', and especially the project's pilot actions in the Mediterranean region. Private land conservation is an approach that has a lot of potential for expansion in the region, with some good examples already in place.

Eurosite had a large role in preparing for and organising the Seminar, as a member of the ECNC-led consortium of partners that supported the EC in the development and implementation of Natura 2000. The Seminar was hosted in Limassol by our member Terra Cypria, the Cyprus Conservation Foundation.

# Workshops, trainings and other events

How can people and the economy benefit from nature? Stories from citizens conference, 7 June, Brussels

With this conference, we aimed to inform, inspire and provide participants with arguments for discussions in the European Parliament that will or should involve issues related to the natural environment. Why? Because for many challenges our society faces today, such as air pollution, climate change, land use changes, droughts, and economic crisis, the solution is – nature.



# One Site, One Plan. Integrated Conservation Management, 7-8 June, Amersfoort

At the beginning of June, the two-day conference 'One Site, One Plan' on integrated conservation management took place in Amersfoort, the Netherlands, organised by Natuurmonumenten, Staatsbosbeheer, Natural England and Eurosite. Dutch and UK national conservation organisations have been working closely together on a new approach to the management of conservation sites.

Therefore the workshop evolved around this approach that:

- is adaptive and integrates planning, implementation, monitoring and evaluation;
- is scalable, integrating the management of individual sites with the management of site networks;
- harmonises conflicting interests by integrating all land interests into a single, dynamic site plan;
- is software supported, integrating mapping, data and documents to create a one-stop information system;
- enables organisations to integrate information from other sites into their site management.

In the conference we had presentations from practitioners, a choice of workshops, and site visits to experience how it works in the field with regards to Natura 2000 implementation and further site management. Above all, the conference was designed for delegates to share their 'real-life' practical experiences (the good and the bad) of adaptive management so participants could take home new ideas for their own organisations and sites.

# Priority Activity 2: An online platform to allow members to request and receive specialist information relevant to their needs

In the previous working year information was collected to fill such a platform. Throughout 2017 additional content was collected, after which the Eurosite Thematic Library was launched towards the end of the year. Thematic pages include: management planning, communication, ecosystem services, monitoring, forestry, funding and resources, green infrastructure, climate change, invasive species, marine and cosatal, tourism, wilderness and policy. New topics are considered based on the demand for information coming out of the Eurosite network. Eurosite Working Groups have an important role in collecting and generating the knowledge that populates the thematic library section pages.

# Priority Activity 3: Working groups on interesting / specific issues

In 2017, the work of our Working Groups has continued. These working groups are stimulating the dialogue and the exchange of information on the relevant topics, by organising thematic events and exploring joint work possibilities through joint projects. Accompanying communication and promotion of their activities and results helps awareness raising on the topics they cover. The activity of the working groups strengthens the Eurosite network by increasing the knowledge exchange. The Economics and Ecosystem Services Working Group (13 members from 11 organisations) has met several times throughout the year, as did the Marine and Coastal Protected Areas Working Group (21 members from 18 organisations) and the Wetlands and Climate Change Working Group (12 members from 11 organisations).







Objective 2: A Gold Standard for Information - Eurosite is recognised as a the leading source of information about best practice in nature site management and related European matters

Priority Activity 1: Advice on site management in relation to conservation and development

# Database Filemaker Pro

With more information entered in 2017, the database has become more and more useful. Also, after having gained some experience in working with it, additional functionalities were added to the database, based on the ideas that came from using the database in day-to-day work. For example, delegates lists of events can be entered into the database, after which they are processed into new contacts. Participants that already were included in the database get an automatic note at their profile mentioning they have attended the event.

# **Eurosite Integration Fund**

The Eurosite Integration Fund was put in place to offer financial support to members when travelling to Eurosite workshops, meetings, seminars or other events. The total number of people supported in 2017 is 13 with 16 subsidies.

# Natura 2000 branding

In aiming to promote the benefits of Natura 2000 to society, the branding campaign was kicked-off early 2017. A functional searchable website database is online. The website is a result of the work which started in 2016. It is a searchable database of products and stories concerning successful partnerships, demonstrating the socio-economic benefits the Natura 2000 sites provide for local stakeholders. The products that are promoted all have a clear link to Natura 2000 sites and there is a mutual benefit for both the Natura 2000 site and the product and its producer. At the end of 2017 the website displayed 73 products and 6 stories about partnerships, covering 10 EU member states. A social media branding campaign was launched during the Nature's benefits: Stories from citizens conference in Brussels (June 2017).

# Farmer's Pride

Eurosite attempted to better connect with academia during 2016. The attempt was successful in that a partnership was formed with the intention to submit an Horizon 2020 proposal. The University of Birmingham led the development of the proposal and the consortium. Eurosite is pleased that the submitted project proposal was accepted and a contract was awarded. In 2017, a kick-off meeting was organised in Ancona, Italy. Eurosite planned to attend this meeting, but was unfortunately unable to, due to



weather circumstances in the Netherlands. The Farmer's Pride project will be executed in 2017-2020. Farmer's Pride is a project involving a diverse range of stakeholders. We are building a collaborative network for on-site conservation and sustainable use of Europe's plant diversity for food, nutrition and economic security throughout the region.

# European Private Land Conservation Network (LIFE ELCN)

In 2016 a proposal was developed for the Development of a European Private Land Conservation Network (ELCN) and submitted to the LIFE Preparatory Call for Proposals. The proposal was successful and the project began in 2017. Eurosite has the leading role in the networking and project communications. If the project is successful, Eurosite will become the secretariat for the newly established Network after the project has ended. The ELCN network will be officially launched during the Eurosite Annual Meeting in 2019, which will also be the final conference of the



project. This LIFE project is led by NABU (Germany), and other partners are Natuurpunt (Belgium), Montis (Portugal), Fundacion Biodiversidad (Spain), Fundatia ADEPT (Romania), ELY Centre Lapland (Finland), IMA Europe (EU) and WWF Oasi (Italy). In 2017, the project website was launched and a kick-off meeting took place in June. Also, a survey was carried out in order to identify existing private land conservation initiatives. Lastly, Eurosite's Network and Development Manager attended a study tour in Colorado that was organised by the International Land Conservation Network to inspire a delegation of the LIFE ELCN project partners.

# **Eurosite Twinning**

Twinning has always been an important part of Eurosite's work. In 1987 – the European Year of the Environment – the European Natural Sites Twinning Programme was launched with the financial support of the European Commission and to support the cooperation of nature conservation management organisations from across Europe. Eurosite was born from this Twinning Programme, and ever since then we have been facilitating twinnings of natural sites across Europe. The attentive reader will have noticed that this means that 2017 reflects 30 years of Twinning. Therefore, 2017 was proclaimed as 'The year of Twinning'. Throughout the year, four new twinnings were realised and the Eurosite Twinning Guidelines have been revised and translated into French and Spanish.

Priority Activity 2: Training events - at various levels to suit Members' needs

Trainings that were given this year comprise the One Site, One Plan. Integrated Conservation Management workshop and the Natura 2000 Monitoring workshop. Both trainings are described under Priority Activity 1 of Objective 1 of this report.

Priority Activity 3: Technical information about funding, project management and legislative changes

Through our website, social media and monthly eNewsletter we have shared the latest information about funding and site management, as well as updates on legislative changes and developments in European environmental policy. Probably the most important topic in this field was the Fitness Check evaluation of the EU Birds and Habitats Directives that resulted in the Action Plan for nature, people and the economy. There is a need for a substantial improvement in the implementation in close partnership with local authorities and different stakeholders in the Member States to deliver practical results on the ground for nature, people and the economy in the EU. Eurosite has closely followed this topic by regularly publishing updates throughout the year, in several of the 12 monthly eNewsletters. Additionally, we attended the Conference on the EU Action Plan for nature, people and the economy in Brussels. In addition, a thematic eNewsletter was published in 2017, prepared with the support of the Marine and Coastal Protected Areas Working Group.

Objective 3: Advocacy for site-based nature - Eurosite provides the advocacy that is required at the EU level to provide political and practical support for site-based nature conservation in Europe

Priority Activity 1: Representation for Members at European level to provide a role in policy making

In 2017, Eurosite attended a number of key meetings and events in Brussels in order to represent the members and ensure that the members remain informed about the latest nature-related policy processes:

- January: kick-off meeting of a new service contract related to the Natura 2000 Biogeographical Process:
- February: Working with Nature for Disaster Risk Reduction and Climate Change Adaptation;
- April: LIFE NGO Info Day;
- April: The European Solidarity Corps Stakeholder Forum;
- May: Boreal Steering Committee meeting in Brussels;
- May and November: biannual European Habitats Forum meetings with DG Environment;
- June: Conference on the EU Action Plan for nature, people and the economy;
- November: EU Expert Group on the Birds and Habitats Directive (NADEG).

# Priority Activity 2: Timely information to Members about what is happening at EU level

We regularly provide our members with relevant news and updates in EU policy development. While using our communication channels (website, social media and the eNewsletter) to keep the Eurosite network informed, we also ensure that we send a report back to members about meetings and events attended in Brussels. This provides many of our members, who do not have the resources to attend such events, with a valuable service. Both the website and the eNewsletter contain a 'Brussels section' especially for the purpose of transmitting information on what is happening on EU level.

Priority Activity 3: Effective communication channels with the European Commission, working in both directions, on policy and funding

Eurosite has been a reliable partner of the European Commission ever since our establishment in 1989. The emphasis of this cooperation has always been on building a two-way relationship with the European Commission. In 2017 there have been multiple occasions on which the Eurosite President had meetings with the European Commission: on 20 January 2017 he had a meeting with the DG Environment Nature Protection Unit about Natura 2000 implementation in Flanders, and another meeting on 14 December 2017 meeting with the same unit about Nitrogen Deposition in Natura 2000 sites.

Objective 4: Building a strong future - Eurosite is a resilient organisation with the human and financial resources necessary to deliver the expectations of the members

In 2017, Eurosite was successfully involved in LIFE ELCN and Farmer's Pride. The European Private Land Conservation Network and the Farmer's Pride project will both last three years. For more information see Objective 2, Priority Activity 1.

# Friends of Eurosite

Friends of Eurosite are nature conservation related organisations or networks with which we have established a long-term working relationship. Friendships are formalised through a Friends of Eurosite agreement, which sets out the goals for the friendship and is reviewed on an annual basis.

In 2017 CEEweb for Biodiversity became a 'Friend of Eurosite'. Given the clear complementary aims of Eurosite and CEEweb for Biodiversity, particularly regarding the exchange of knowledge and experience, geographic coverage, and a number of common themes addressed by the two networks, both organisations expressed interest to formalise their working relationship.

CEEweb for Biodiversity is a network of non-governmental organisations in the Central and Eastern European region working in 20 countries. The mission of CEEweb is the conservation of biodiversity through the promotion of sustainable development. CEEweb works through advocacy, influencing decision making, common projects, capacity building, networking and awareness raising. It targets its members, local, national and international decision makers, NGOs and NGO networks, companies and the scientific community.

The Migratory Birds for People Programme (MBP) has been a friend of Eurosite since July 2015 and the friendship agreement was renewed in 2017. The agreement was signed at the MBP Annual Meeting in Remerschen, Luxembourg. Eurosite's Communications and Membership Officer participated, gave a presentation on Twinning, and gave a workshop on the use of social media in the nature conservation sector.



SER Europe also became a friend of Eurosite in September 2017. SER Europe is a network of restoration experts, exchanging knowledge and expertise for the promotion of ecological restoration in Europe. Their aim is to promote ecological restoration as a means of sustaining the diversity of life on Earth and re-establishing an ecologically healthy relationship nature and culture.









Memorandum of Understanding with ECNC - European Center for Nature Conservation Following a meeting to explore the continuation of the Memorandum of Understanding between Eurosite and ECNC, unfortunately ECNC ceased to exist in December 2017.



# Priority Activity 2: Secure and develop present funding: membership fees and funding

Compared to 2016 Eurosite received slightly less membership fee income in 2017. We welcomed new individual members, but sadly also received a couple of resignations. Fortunately, we had been successful in securing EU NGO Funding for 2016/17. In 2015, Eurosite successfully applied for an EU NGO Framework Partnership Agreement for the years 2016 and 2017, based on the new Eurosite Strategy 2015 - 2020, which we wrote together with our members.

To realise an expanding Eurosite network and membership base, the Eurosite Secretariat attended a marketing training given by Gert Koot of Branded Entertainment. It created a clearer insight into tactics for ensuring membership satisfaction and therefore a higher retention rate, as well as effective approaches for recruiting new members. Lessons learned were converted into a membership recruitment strategy, a promotional recruitment video and a clearer overview of membership benefits.

# Priority Activity 3: Create clear financial projections (1-5 years) and build a financial reserve to improve cash flow

Eurosite's main aim in 2017 was to closely monitor the budget and cash flow and to review any outstanding membership fees. Despite our best efforts, the financial result for 2017 unfortunately could have been better: we were able to add an amount to our reserves to improve cash flow, but because of ECNC's bankruptcy we suffered a loss instead of building a financial reserve. Eurosite aims to participate in multi-annual contracts which will help to make clearer financial projections for years to come.

# 4. The Eurosite Network - as of December 2017

# 5. Report of the Treasurer 2017 <sup>1</sup>

2017 has been a challenging year for Eurosite. We worked on several projects but could unfortunately not receive all the expected revenue. More specific, we had problems collecting the revenues for the service contract regarding the Natura 2000 Biogeographical Process, led by ECNC. Fortunately, we managed to secure EU NGO funding, which supported the implementation of our Strategy (2015 - 2020) greatly. In addition, we were able to secure extra project income for the Horizon 2020 project Farmers Pride and LIFE ELCN – European Private Land Conservation Network.

As a result of the ECNC problems and bankruptcy, Eurosite incurred a loss for 2017 of 8,770 euro. We however managed to control the 2017 cash flow and successfully applied for a European Commission Specific Grant Agreement for 2018, as part of a new Framework Partnership Agreement.

# Resolution n° 1
